Art. 1 - Purpose of the scholarship

The University of Florence hereby establishes five scholarships for EUR 6,000 (before any taxes) for international students with Afghan citizenship who are enrolling for the first time in the academic year 2022/2023 in one of the open-access Master's degree programs delivered in English, listed in Annex 1.

The scholarship amounts under this notice will be from the resources of Project_D.M.752_2021.

Art. 2 - Incompatibilities

The scholarships in this notice are incompatible with scholarships granted by other public and/or private institutions (except for those intended for Erasmus+ mobility).

Art. 3 - Eligibility Requirements

In order to participate in this selection, the following requirements must be met as of the notice deadline:

- have Afghan citizenship;
- having applied for pre-enrollment at the University of Florence for the academic year 2022/2023 through the University platform and having obtained the required Type "D" national entry visa for "university study/admission."
- have obtained clearance for admission for the academic year 2022/2023 in one of the Master's degree programs listed in Annex 1.

Art. 4 - Submission of the application

The application for participation in the selection (Annex 2) should be sent, by 25/11/2022 at 1:00 pm (Rome time), to the email address internationaldesk@unifi.it. You must put in the subject line "Afghanistan Scholarship - your Last and First Name," together with a copy of your passport and national entry visa type "D" for "study/university admission."

Applications that are not correctly filled out or not accompanied by all required documentation will not be considered. Applications cannot be delivered by any other method than the one mentioned above, nor can they be sent to a different email address than the one above.



Art. 5 - Award criteria and ranking

The ranking list is formed according to the chronological order of arrival of applications.

The ranking list will be published on the University web page "Students with International Protection" (<https://www.unifi.it/vp-12027-students-with-international-protection.html>) and the University's official notice board.

Successful candidates will receive appropriate and timely notification via email from the International desk.

Article 6 - Acceptance of the scholarship

Winners will receive a specific communication via email stating how and when to accept the scholarship.

Art. 7 - Payment of the scholarship

The scholarship will be paid to the successful candidates only after the following:

1. sending the statement of acceptance of the scholarship in the manner and by the deadline communicated to them;
2. their arrival in Italy and application for a residence permit for study purposes;
3. the completion of the enrolment procedure for the Master's degree program for which clearance has been obtained and the payment of the enrolment fee for the academic year 2022/2023 by the deadlines stipulated in the Manifesto of Studies for the academic year 2022/2023;
4. the opening of a bank account in Italy at an Italian bank in the winner's name or co-owned;
5. signing the scholarship award contract, whereby the winner agrees to accept the terms and conditions related to the scholarship and confirms that he or she does not fall under any of the conditions of incompatibility outlined in Article 2 of this notice.

Art. 8 - Revocation of the scholarship

Students who give up their studies or transfer to another university lose their benefits under Article 1 and are required to return the scholarship awarded.

Art. 9 -Data processing and right of access following Art. 13 GDPR 2016/679

Personal data will be processed in compliance with the provisions of the General Regulation on the Protection of Personal Data (EU Regulation 2016/679 of the European Parliament and of the Council of April 27, 2016 (GDPR) on the protection of individuals with regard to the processing of Personal Data and on the free movement of such data, published in the OJEU of May 04, 2016, and the Legislative Decree of June 30, 2003, No. 196 Code on the Protection of Personal Data, as amended.
