<b>Practical-professional profile of the course and industry sector of reference</b>	<p>The course aims to deepen and provide appropriate expertise in psychological and medical fields concerning gender incongruence and variance in various age groups. Therefore, the course includes lectures concerning the biological basis of sexual identity, etiology, psychological and psychiatric framing, multidisciplinary care at different stages of development with reference to international guidelines, and special attention to critical issues related to the Italian territory.</p> <p>The course is aimed at various professional profiles (e.g., physicians, psychologists, biologists, social workers, nursing staff, educators, and pedagogists) who wish to acquire adequate knowledge and tools for the framing and care of gender variance and gender incongruence in various age groups.</p> <p>The duration of the Master is 22 months, and attendance is compulsory for at least 67 percent of the teaching activities (Total of credits 70, including final examination).</p> <p>During the course, it will also be possible to carry out an internship to acquire knowledge and skills concerning gender incongruence and variance in various age groups through observational activities at the Careggi University Hospital, Viale Pieraccini n 6, 50139 Florence.</p>

<p><b>Teaching methods</b></p>	<p>The teaching activities are conducted in person or remotely via the Gmeet platform or in blended mode (in-person and remotely) in relation to the evolution of the Covid-19 situation.</p>
<p><b>Language of instruction</b></p>	<p>Italian</p>
<p><b>Attendance requirements</b></p>	<p>at least 67% of the lectures</p>
<p><b>Location of the course</b></p>	<p>In-person teaching takes place at the Department of Biomedical, Experimental and Clinical Sciences "Mario Serio" - AOUC, Viale Pieraccini n 6, 50139 - Florence.</p>

<b>Foreseen lecture schedule</b>	Classes will be held on the first Monday, Tuesday, and Wednesday of the month from March/April through July/September
<b>Examinations procedures and schedule</b>	The assessment of educational activities consists of examinations at the end of each year with a grade expressed in thirtieths and possible mention of honors or with a pass/fail grade in some cases and communicated to the Student Administrative Office by the Coordinator of the Master Course.
<b>Final examination</b>	The final examination consists of an interview.
