<b>Practical-professional profile of the course and industry sector of reference</b>	The Master's program, established in 2000, aims to train high-level executives for wine sector enterprises and enhance management skills, with particular reference to production specifics, market conditions, and management of the wine enterprise. The teaching involves a commitment of more than 380 hours, divided into lectures, practical exercises, and seminars with practitioners. A technical-practical internship in companies or institutions in the field is also planned.
<b>Access prerequisites</b>	A bachelor's or master's degree or single-cycle degree awarded according to the system under Ministerial Decree No. 270/2004 or Ministerial Decree No. 509/1999 or previous systems.
<b>How the admission procedure takes place</b>	The selection of candidates consists of: <ul style="list-style-type: none"> <li>- the evaluation of the CVs that may be attached to applicants' online applications, which will consider the type and grade of the degree, as well as any other qualifications and experience obtained in the wine sector;</li> <li>- a written test on topics related to viticulture and enology, marketing and management, and wine knowledge;</li> <li>- an interview on the same subjects as the written test and a test of English language proficiency (for all candidates) and Italian language proficiency (for foreign candidates).</li> </ul>

<b>Teaching methods</b>	In-person classes
<b>Language of instruction</b>	Italian
<b>Attendance requirements</b>	67%

<b>Foreseen lecture schedule</b>	Classes are held on Wednesdays, Thursdays, and Fridays.
<b>Examinations procedures and schedule</b>	Assessment will take place following the completion of each subject. It will consist of either open-ended or closed-ended tests or the submission of papers related to the topics developed in the specific subject, according to the procedures established by each individual teacher.
<b>Final examination</b>	The final examination consists of the presentation of a business plan.
