Practical-professional profile of the course and reference job market	The Master offers high-level theoretical-practical training in pediatric dermatology. Pathologies of pediatric interest with a dermatological focus will be evaluated. The diagnostic-therapeutic pathways of the main dermatological pathologies of the pediatric age will be evaluated with a transversal and multidisciplinary approach. In particular, pathologies commonly found in outpatient settings and dermatological pathologies of allergological, rheumatic-immunological, neurological, infectious disease and surgical interest will be treated. The main genodermatoses will also be discussed and the sector of vascular anomalies will be explored in depth. This master's degree will be particularly suitable for doctors, doctors in specialist training and specialists in dermatology and paediatrics. The main training aims of this Master's course focus on the acquisition of basic and ultra-specialist pediatric dermatological skills that are fundamental in the diagnosis and in the management of complex pathologies with systemic involvement.

Multidisciplinary clinic for vascular anomalies.
