<b>Practical-professional profile of the course and reference job market</b>	<p>The basic text adopted by the Social Affairs Committee of the Chamber for the bill for the establishment of the figure of the basic psychologist recognizes the right to psychological assistance in order to guarantee individual and collective psychological health and well-being, as well as to ensure the psychological services to citizens in the context of primary care medicine. Furthermore, it establishes the primary care psychology service in each local health authority, organized at the health district level. This service is aimed at guaranteeing a first level of psychological intervention which provides for the rapid reception and analysis of the citizen's request and the promotion of a complementary activity with other health and social-health services, through the creation of a cooperation system with general practitioners and paediatricians of free choice, as well as with other specialist doctors and health and social-health professionals present in the area.</p> <p>In order to prepare psychologists to carry out these complex functions, the Master intends to develop advanced knowledge and skills in the reserved and typical activities of the psychological profession in the context of primary healthcare, with a specific focus on the tools of psychological sciences. The main training objectives can be summarized as follows: (1) widespread knowledge of the psychological, medical and psychosocial care resources available in the area to be brought to the attention of citizens; (2) prevention, interception and timely response activities to situations that compromise well-being and psychological health, with particular reference to emotional distress linked to adaptation in the different phases of the life cycle (childhood-adolescence, adulthood, senescence) or due to stressful events such as bereavement, job loss, school problems, separations, etc.; (3) poor diagnoses, chronicity or relapse of disease and difficulty in adhering to treatment; (4) issues related to migration and interculturality; (5) monitoring of psychological distress to guide local health policies in this regard.</p>
